Dear Mr Coyle,

I refer to the request which you have made under the Freedom of Information Act 2014 for access to records held by this Department, as follows:

Access to any minutes/memos/briefings/correspondence relating to the meeting between Aisling Hassell of Airbnb and Minister Coveney during 2018. Details of the meeting are outlined here: https://www.lobbying.ie/return/36919/airbnb-ireland-uc

I have identified 7 documents that fall within the scope of your request. The records are listed in the schedule attached. I have made a decision to grant 6 documents and refuse access to one on the basis of Section 36 of the Act.

In relation to the record exempted under Section 36 of the Act – *Commercially sensitive information*, I have taken the public interest into account, inter alia, the need to achieve openness, transparency and accountability in decision-making. I have considered whether the public interest would be better served by releasing the record in question in terms of the right of the public to have access to information and the need for an open and accountable civil service. To ensure the company concerned would not be unduly impeded in the effective pursuit of their business, I have decided the wider public interest is best served by refusing access to the commercially sensitive information contained within the scheduled records.

#### Right of Appeal

Should you wish to appeal this decision, you may do so in writing to the Freedom of Information Unit, Department of Foreign Affairs and Trade, 76-78 Harcourt Street, Dublin 2 or by email to <a href="mailto:foi@dfa.ie">foi@dfa.ie</a>. A fee applies for an appeal for access to non-personal information; the level of this fee has been set at 30euro. You should make your appeal within 4 weeks (20 working days) from the date of this notification. However, the making of a late appeal may be permitted in appropriate

circumstances. The appeal will involve a complete reconsideration of the matter by a more senior member of the staff of this Department.

Dear Taoiseach Varadkar,

Brian Chesky, Airbnb's CEO and co-founder is in Dublin on 13 September and we would kindly like to request a meeting with you to discuss our commitment to responsible growth and fair home sharing in Ireland.

According to our <u>Insight Report</u> published in January, Irish hosts have welcomed close to 1.2 million guests in one year on Airbnb resulting in €115 million earned by local households. By welcoming visitors from around the world into their home, a typical host on Airbnb in Ireland earns - on average - €3,500. Hosts in Ireland are passionate local ambassadors that offer huge value to guests by directing their spending with authentic insider recommendations to local restaurants, shops and sites - with the average host in Ireland having lived in their hometown for 26 years.

Ireland is Airbnb's international home. The first Irish hosts started welcoming guests in 2009, and since then we have put down roots here and grown our own presence to number over 500 employees, as well as supporting many hundreds more through our partnerships with companies across the country. We are very proud to be part of the thriving tourism sector in this country. Airbnb are in full agreement with the Government that there needs to be rules put in place, but they need to be balanced and targeted at only those who are acting "commercially" and not damage the lives of those who are benefitting from the abovementioned extra income.

To that end Brian would appreciate the opportunity to meet with you to discuss this further as well as Airbnb's commitment to Ireland and our future plans for growth.

We will follow up with your office to try and secure this time.
