Dear Mr. Foxe,

I refer to the request which you have made under the Freedom of Information Act 2014 for access to records held by this Department, as follows:

- **copies of all correspondence between DFA and Dept of Public Expenditure and/or Department of Finance regarding purchase and construction of new Ireland House in Tokyo in period 1 Sept 2017 to date of receipt of this request.**
- **copies of all correspondence (written and electronic) from Ambassador Barrington relating to purchase and construction of new Ireland House during the same period.**

I refer also to the acknowledgement of your request which was sent to you on 16<sup>th</sup> May 2018

I have identified 36 records that fall within the scope of your request. The records are listed in the schedule attached. I have made a decision to refuse 21 of the records. I have made a decision to part-grant 10 of the records. I have made a decision to grant 5 of the records.

As you will have seen in other responses to requests, the Department is happy to release records once projects are completed but it puts us at a commercial disadvantage to do so while planning a process or project there for where access has been refused, the records are exempt from release under section 15. (1)(d) Section 15(1) (i) (i) Refusal on administrative grounds, section 32(1)(ix) Law enforcement and public safety, section 36. (1)(b), section 36. (1)(c) Commercially sensitive information, under section 37. (1) Personal Information and under section 40. (1)(b) Financial and Economic interests of the State.

This Department continues to review all options in relation to official accommodation in all countries where we have diplomatic representation so as to ensure value for money and the delivery of the Department's strategic objectives. Where possible, we also examine the scope for purchase/construction with a view converting rental payments in cities, such as Tokyo, into a long term asset for Ireland. Concerning Tokyo, we continue discussions with the Department of Public Expenditure and Reform. In relation to this work, it would not be appropriate to release information on our plans as there is an ongoing commercial sensitivity. The primary objective is to ensure that any investment internationally offers value for money for the Irish taxpayer.

We are not re-issuing documents to you in this FOI response that you have sent to this Department or documents that we have already sent to you to include e-mail correspondence relating to this FOI or documents already in the Public Domain such as already issued FOI's, PQ's and so on.

### Right of Appeal
