Dear Mr. Gallagher,

I refer to the request which you have made under the Freedom of Information Acts 1997 and 2003 dated 2 January 2014, for records held by this Department, in which you requested:

- Documents detailing the cost of restocking the Department of Foreign Affairs wine cellar in 2013
- Documents detailing the wine list held, including names, year, origin, quantity, unit price and value
- Total expenditure on the restocking of the wine cellar for individual years since 2005, single figure monetary amount only
- Documents detailing any sale of wine in as much detail as possible for 2013

I refer also to the acknowledgement of your request which was sent to you on 13 January, 2014.

Your request for Documents detailing the cost of restocking the Department of Foreign Affairs wine cellar in 2013 falls to be refused under Section 10(1)(a) as no such records exist. Expenditure by the Department of Foreign Affairs and Trade to add to its wine stock for use in relation to State and Official Hospitality in 2013 was nil.

I have identified 3 records that fall within the scope of your request. My decisions in relation to the records are detailed in the schedule below.

Right of Appeal

You should make your appeal within 4 weeks (20 working days) from the date of this notification. However, the making of a late appeal may be permitted in appropriate circumstances. The appeal will involve a complete reconsideration of the matter by a more senior member of the staff of this Department.
