

PENSION - INCOME LETTER

Pension/Income for Thai retirement and Spouse visa

The Embassy of Ireland can issue a standard letter stating your pension/income to be used with your application to Thai Immigration for a Retirement/Spouse Visa.

If you wish to apply for this letter then please submit your application to the Embassy with the following documents:

Documents Required:

- 1. Applicant's original Irish passport + photocopy
- 2. Completed request form below **OR** signed cover letter, indicating your residential address in Thailand, contact telephone number, email address, the amount of your weekly/ monthly/annual pension/income and pension/income name.
- 3. An official letter from your Employer / Government Office / Pension Provider confirming the amount of your annual pension / income (all letters submitted must be on official company headed paper)
- 4. Bank statements (at least 6 months) showing details of the pension/income which goes to your account.

5. Fee: 1,500 Baht

6. Postage fee (optional): 100 Baht
